1. The Board of Directors has acknowledged the Company's operating results according to the Reviewed Consolidated and Separate Statements of Financial Position and Statement of Comprehensive Income for the 3<sup>rd</sup> Quarter (Jul-Sep 2020) which was also sent to SET together with this letter as follows:

The Board of Directors has approved interim cash dividend payment from the operational performance of the 3<sup>rd</sup> Quarter (Jul-Sep 2020) of net profit after income tax of reviewed consolidated financial statements. Dividend per share is approved to be at 0.045 Baht per share or 90% based on the total numbers of 8,198,942,195 issued and paid-up shares; totaling to total dividend payment of 369.0 MB for the 3<sup>rd</sup> Quarter of 2020.

The Board of Directors approved the record date for entitlements to the interim dividend to be November 18, 2020 and the interim dividend payment date will be on November 30, 2020.

3. Board of Directors acknowledged the resignation of Mr.Suvit Samarnpanchai, a director, effective from November 4, 2020 and appointed Mr.Chanin Suppapinyopong as a replacement director, effective November 4, 2020, counting the remaining terms after Mr.Suvit Samarnpanchai.
